3. Payment of the Registration fee. \$10.00. (10% discount for Senior Citizens).
4. Optional three (3) generation pedigree or a five (5) generation pedigree is requested, if available.

Your application will be reviewed within thirty (30) days of application. Those applications that are accepted will receive Registration Certificates. Those denied will receive a written explanation.
